





GAPNA’s Rising Star

Helen Burns: Inspired Toward Gerontological Nursing Excellence

GAPNA’s latest Rising Star is Helen Burns, MSN, ANP-BC, AGN-BC, AOCNP, of the Great Lakes Chapter in Michigan. Helen has been a member of GAPNA for 4 years because she was inspired by our current national President, Michelle Moccia.

Helen is currently in a DNP program at Madonna University, and works for St. Mary Mercy Hospital in Livonia, MI, as the High Risk and Genetics Coordinator.

“Every nursing position I’ve ever held has involved working with older adults in some capacity,” said Helen. “I spent my early years in long-term care, and that experience fostered my compassion for frail older adults. As a medical-surgical RN, and then a chronic hemodialysis nurse, the majority of the population I cared for was older adults. I had the privilege of learning from an extremely gifted nurse practitioner who specialized in geriatrics during my NP education. Cancer is a disease that many older adults face, and my involvement in GAPNA has further equipped me to provide the best possible care to older adult patients facing cancer or risk for cancer.”

Helen manages the High Risk and Genetics Program in the Hope Cancer Center. She identifies patients at high risk for breast, colon, ovarian, uterine, prostate, and other cancers, and sets up individualized risk management plans for surveillance and prevention. She also provides genetic counseling and testing. “Genetics is a very exciting field of healthcare,”



explained Helen. “I love to construct pedigrees and educate patients about how family history impacts their risk for disease.”

Burns received her post-graduate genetics training at the City of Hope (Division of Clinical Cancer Genetics) in Duarte, CA, and remains an active member of their Clinical Cancer Genetics Collaboration of Practice. She was the first nurse practitioner in Michigan to obtain American Nurses Credentialing Center’s *Advanced Genetics Nursing* certification, and was privileged to present the story of her journey to the Centers

for Disease Control and Prevention (CDC) Cancer Prevention team in 2016. She is currently involved in a CDC-funded Michigan Department of Health and Human Services hereditary cancer surveillance project. As a newly elected member of the Michigan Cancer Consortium’s Board of Directors, she will serve with a focus on cancer prevention.

Helen has been married for 26 years to Dennis, with two daughters Hannah (age 22) and Devon (age 18). Helen is proud both of her daughters are working toward careers in healthcare (Hannah in dental and Devon in nursing). Helen is also active in her church and loves to cook.

“With older adults living longer than ever before,” said Helen, “I hope that our focus will be facilitating the best quality of life possible by focusing on health promotion and proactive disease prevention. It is an honor and a privilege to be a GAPNA member!”


